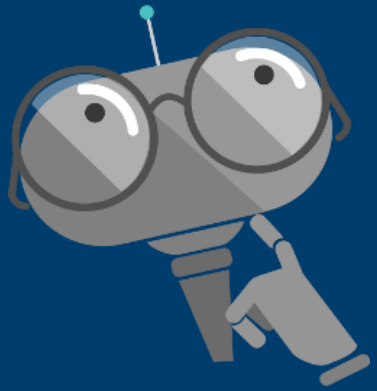

Bots uses conversation as the interface for both internally-facing (employees) and externally-facing (customers) scenarios.

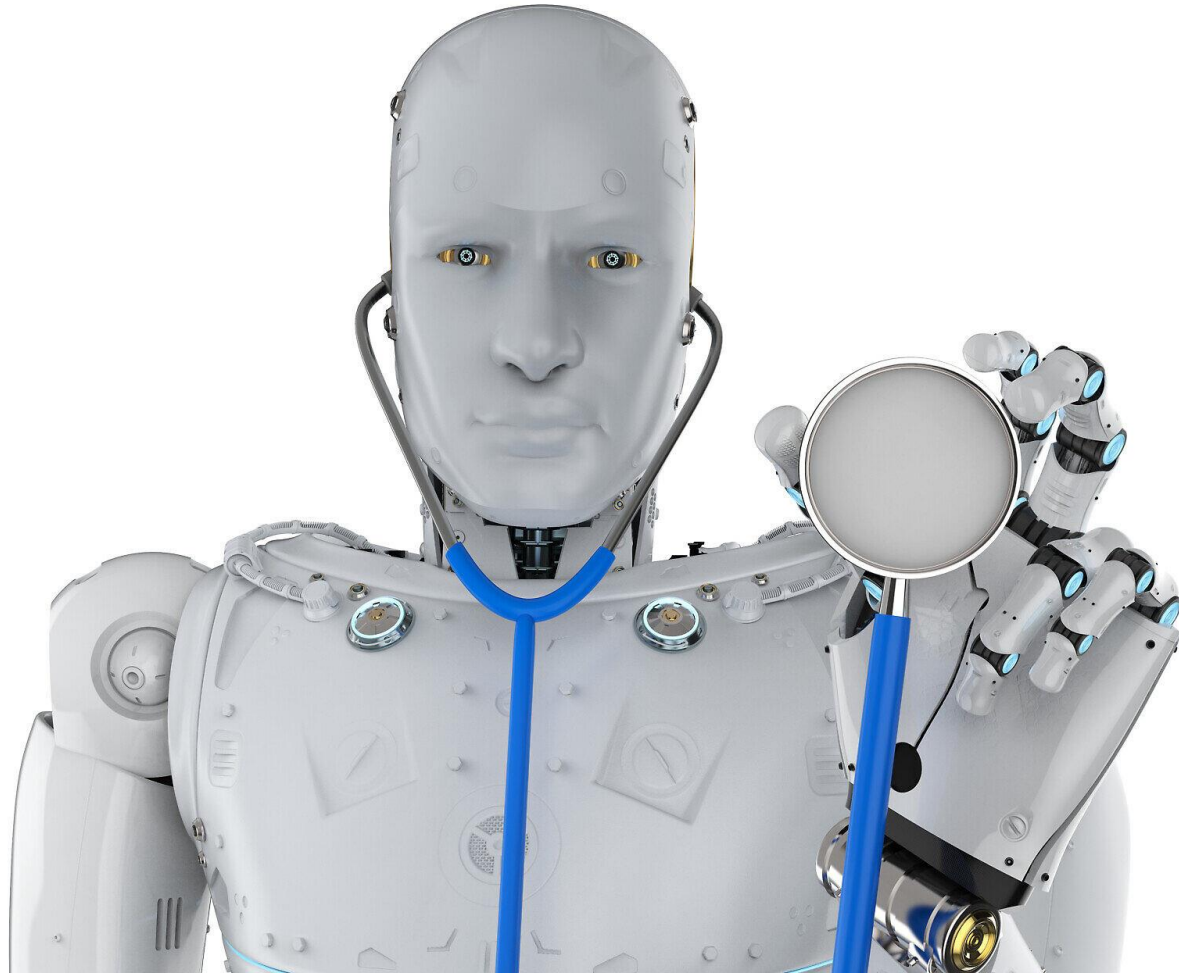
Conversational Apps are an application category of AI-based solution.
